5. The successful bidders should submit photocopy of every tickets along with their invoices for payment.
6. Unconditional quotations like an increase of fares or changes of airlines at time of travel are not accepted.
7. Tender documents should be accompanied by a photocopy of **valid trade license, tax clearance certificate** issued by respective authority.
8. Tender should be accompanied with lump-sum amount of **Nu. 5000/-** only as bid security in the form of draft/cash warrant issued in favour of Managing Director, BBSCL. **Those issuing personal cheques will be rejected.**
9. The bid security of Nu.5000/- of the lowest evaluated bidder shall be retained with organization as performance security and will return only after the delivery of air tickets mentioned in the supply order for the above sector.
10. **In case, the lowest bidder withdraws his/her bid then the second lowest bidder shall be asked to purchase and issue tickets and the difference shall be borne by the lowest bidder.**
11. Quotation without bid security and sealed envelope will be rejected.
