1. The **Bhutan Broadcasting Service Corporation Limited** now invites sealed Bids from eligible and qualified Bidders for the **Supply, Installation, Testing & Commissioning of Broadcast Equipment for BBSCL Television**.
2. Bidding will be conducted through the national and **International Competitive Bidding** procedures specified in the RGoB Procurement Rules and Regulations, and are open to all Bidders from Countries as defined in Section V of the Bidding Documents.
3. Interested eligible Bidders may obtain further information from **Project Manager, HD Upgradation, BBSCL** and inspect the Bidding Documents at the address given below from **7th October, 2022 from 09:00AM to 05:00PM Bhutan Time**.
4. Qualification requirements include: **As specified in the tender document**.
5. A complete set of Bidding Documents in **English** may be purchased by interested Bidders upon payment of a non-refundable fee of **Ngultrum/ Rupees 2000.00 or in equivalent foreign currency**. The method of payment will be either **on cash or direct deposit to the specified account number; [100891832] (Bank of Bhutan (BOB))**. For direct deposit, transaction receipt must be submitted for verification and issuance of **BBSC cash receipt**. 6. Bids must be delivered to the address below at or before **21st November, 2022 at 10:30AM Bhutan Time**. Electronic bidding **shall** be permitted. Late Bids will be rejected. Bids will be opened **physically and electronically** in the presence of the Bidders' representatives who choose to attend in person or on-line at the address below **on 21st November, 2022 at 11:30AM Bhutan Time**.

All Bids shall be accompanied by a Bid Security of **[2% of Bid Price]** in the form of Unconditional Guarantee/Banker's Cheque/Cash Warrant/Demand Draft issued by a reputed Financial Institution in Bhutan acceptable to the procuring agency. If the institution issuing those instruments is located outside Bhutan, it shall have a correspondent financial institution located in Bhutan to make the financial instrument enforceable.
